

Participating Venue Information For Targeted Condom Distribution Program

In alignment with the National HIV/AIDS Strategy, the Office of AIDS' **Targeted Condom Distribution Program** targets the following populations: **people living with HIV; partners of people living with HIV; transgender individuals; gay men and men who have sex with men (MSM); people who inject drugs (PWIDs); sexual and needle-sharing partners of gay men, MSM, and PWIDs; and women at high risk of acquiring HIV via their sexual partners, injection drug use, and/or sex work.**

Venues in the California Project Area* who specifically serve one or more of these populations are eligible to participate in providing free condoms to their clientele. Venues (e.g. **community-based organizations, community health centers/clinics, HIV-care programs, LGBT centers, bars, dance clubs, sex clubs, bathhouses, local business partners, etc.**) should be located in communities where data show HIV is most prevalent, with specific attention placed on those who serve the targeted populations that are disproportionately affected most by HIV/AIDS. Youth are not considered at high-risk for HIV infection unless they fall into one of the above categories. If a venue serves youth and/or other populations outside of the targeted populations listed above, they can find free condoms for their clients at: www.teensource.org or www.condomfinder.org.

Please note, orders take an average of 2-3 weeks to be processed and delivered.
